

CITY OF BATAVIA
KANE COUNTY, ILLINOIS

The original site of the village on the east side was platted by Van Nortwick, Barker, House & Co. in 1837, and on the west side by John Van Nortwick in 1844. In April 26, 1856, twenty-seven votes were cast in Batavia in favor of village incorporation and eleven against. At the first election of village officers, held May 10, 1856, T.C. Moore, served as Moderator and J.C. Pindar as clerk. John Van Nortwick, Orsamus Wilson, M.N. Lord, D.U. Griffin and George E. Corwin were elected as the first Board of Trustees. Batavia was incorporated as a Village in accordance with an election held April 26, A.D. 1856 and the first officers were elected at an election held May 16, 1856. Incorporated as a city, under the general law, June 9, 1891. (Batavia Book)
